# SCHOOL CURRICULUM REVIEW TASK FORCE MEETING MINUTES JANUARY 30, 2010

# CALL TO ORDER

## 2. COMPLETE REVIEW OF REGULATIONS

The review began with Section 2411 (f). The task force recommended changes to the regulations, as follows:

# 3. REVISIT DEFERRED ITEMS

#### A. CAT

The task force decided to leave "CAT" out of the language to leave open the possibilities of changing technology.

#### B. DISTANCE LEARNING

The group discussed the restrictions set out in Section 2411 (a)(2) that states, "All tests used to qualify students to sit for the CSR exam shall be transcribed on campus under supervision." Suggestions were taken under consideration for allowing students nationwide to take courses online.

The task force recommended the following additional changes to Section 2411 (a):

- Add "lecture or non-lecture" after classroom on the first line

- Delete "All" and capitalize "tests"
- Delete "on campus" in the first and second sentences

### C. HOURS REQUIRED

Task force members mentioned that each quarter is equal to 60 hours. Rounding the hours may make it easier for the schools to offer the courses during the regular quarter session.

The task force recommended changes to the hours required in each topic, as follows:
